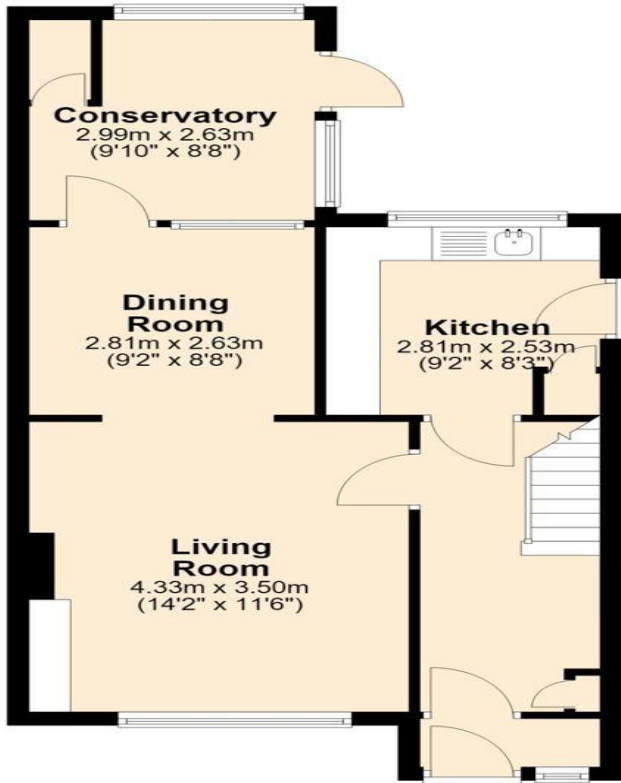

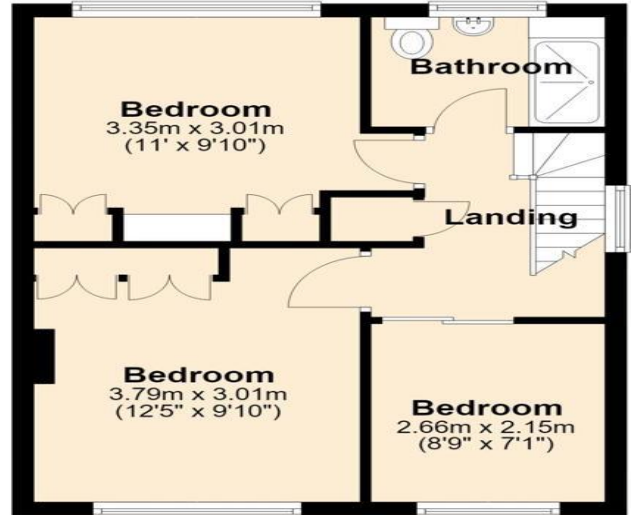
### Ground Floor
