A well-presented two-bedroom ground floor apartment situated within the popular Logun Court development, conveniently located just off Lowestoft High Street. Offering approximately 53.4 sq. m. (574.6 sq. ft.) of accommodation, the property provides a practical layout with easy access to the town centre and the seafront.
