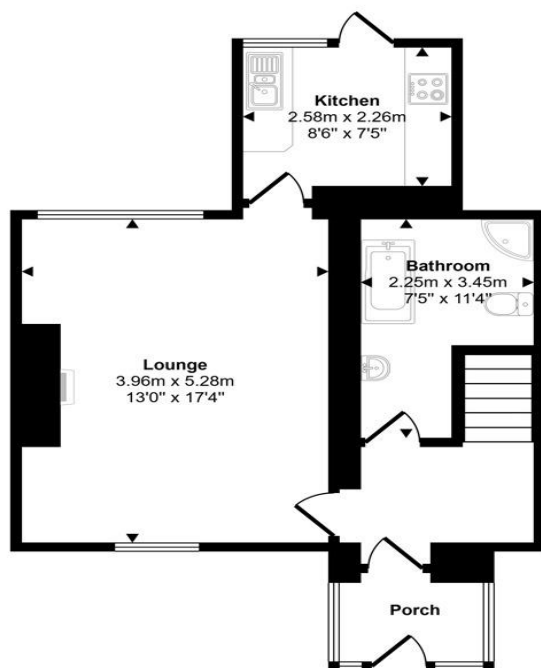

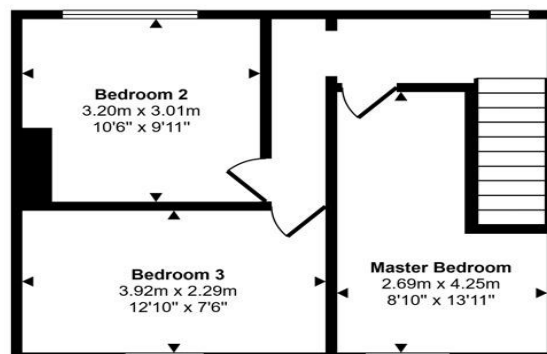

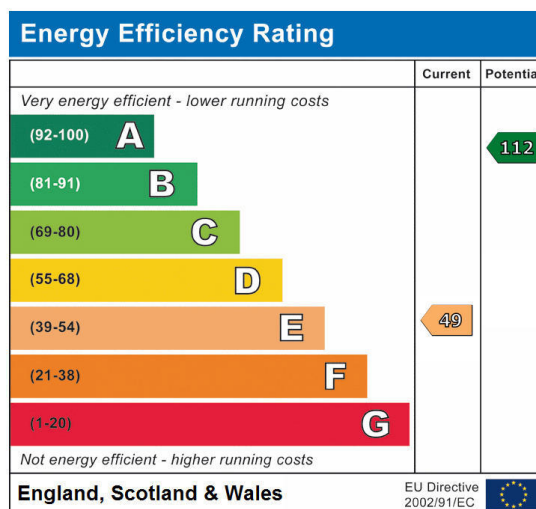


Ground Floor
